**Background**

On March 27, 2020, Congress passed, and the President signed into law the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provides \$30.75 billion nationwide in an Education Stabilization Fund to prevent, prepare for and respond to the coronavirus, of which:

- \$13.2 billion is for the Elementary and Secondary School Emergency Relief Fund (ESSER) to support the ability of local educational agencies (LEAs), including charter schools that are LEAs, with emergency relief funds to address the impact that Novel Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on elementary and secondary schools across the nation; and
- \$2.95 billion is for the Governor's Emergency Education Relief Fund (GEER) which provides grants to Governors for the purpose of providing educational agencies with emergency assistance to address the impact of COVID-19.

Governor's Emergency Education Relief Fund (GEER)

New York State has been allocated \$164.2 million under the Governor's Emergency Education Relief Fund (GEER). The entirety of New York State's GEER funds were programmed in the 2020-21 enacted New York State budget through the application of a "pandemic adjustment" to partially offset the state share of state aid to school districts. Pursuant to the direction of the Governor's Office and the Division of the Budget, GEER funding is being allocated to the State's 673 major school districts. GEER funds are not being allocated to LEAs that are charter schools, Special Act School Districts, or school districts employing fewer than eight teachers. These funds will be allocated to eligible school districts using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent fiscal year (2019-20).

Elementary and Secondary School Emergency Relief Fund (ESSER)

New York State has been allocated \$1.037 billion under the Elementary and Secondary School Emergency Relief Fund (ESSER). ESSER funds to school districts were programmed in the 2020-21 enacted New York State budget through the application of a "pandemic adjustment" to partially offset the state share of state aid to school districts. ESSER funding is being allocated all LEAs, including charter schools and Special Act School Districts, that received 2019-20 Title I, Part A subgrants. Pursuant to the terms of the CARES Act, Local Educational Agency (LEA) allocations were calculated using the relative shares of grants awarded under Title I, Part A of the Elementary and Secondary Education Act (ESEA) for the most recent fiscal year (2019-20).

The Salmon River Central School District Administration at each level (Elementary, Middle and High School) will collaborate with all general education and special education teachers prior to the opening of school in September to complete a needs assessment to determine and prioritize identified needs as a result of COVID-19. This needs assessment will determine teacher professional learning needs as well as student learning needs. This process will enable us to identify gaps that occurred in the instructional curriculum between March and June and also identify skill gaps and regression especially with our younger learners (k-3) and our special education population. The teams will meet as grade levels and also in vertical teams and by department. By doing so the teams will review available data to identify grade level standards, curriculum, and skills that must be taught to fill gaps in learning and to build prior knowledge necessary for success. Surveys will also be completed to assess teachers’ proficiency of virtual -technology use and best practice teaching strategies for delivering remote instruction. Consultants and Salmon River staff with expertise in identified pedagogy and technology will deliver Professional Development to staff to address gaps in pedagogy and technology, thus enabling teachers to be better prepared to provide quality lessons that fully engage students during remote and hybrid teaching situations.

- 2. **Does the LEA intend to use GEER funds to promote or support remote learning?**

- 3. **In the space below, please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services (150 words or less).**

The District intends to assess and identify student learning gaps resulting from the disruption in educational services based on data collected and analyzed from new diagnostic assessments and/or pretests (assessments include but are not limited to: ready - Math and Reading diagnostics, Running records for reading and math, anecdotal progress notes from Spring, 2020 and summer sessions), an analysis of unit lesson plans and curriculum maps to identify curricula that was not taught during the closure, a review of student work, course grades, attendance and participation data, and the teacher-student-parent communication logs that were maintained to monitor student engagement and progress. To address the identified gaps, teams of Pre-K-12 teachers will meet as grade levels and also vertically to create consistency in planning for instruction. By doing so the teams will identify grade level standards curriculum materials and skills-related materials that must be shared from previous grade levels in order to fill these gaps during tier 1 instruction, while still teaching to present grade level standards. A two- tiered approach with classroom teachers and interventionists will target intervention for students with more intense needs. Increased frequency and smaller group sizes will be utilized in these tiers of services during both pull out and push in sessions, based on individual and class needs and availability of staff resources. Administration will be involved with teachers in this process to support curricular and staffing needs.

The Salmon River Central School District Administration at each level (Elementary, Middle and High School) will collaborate with all general education and special education teachers prior to the opening of school in September to complete a needs assessment to determine and prioritize identified needs as a result of COVID -19. This needs assessment will determine teacher professional learning needs as well as student learning needs. This process will enable us to identify gaps that occurred in the instructional curriculum between March and June and also identify skill gaps and regression especially with our younger learners (k-3) and our special education population. The teams will meet as grade levels and also in vertical teams and by department. By doing so the teams will review available data to identify grade level standards, curriculum, and skills that must be taught to fill gaps in learning and to build prior knowledge necessary for success. Surveys will also be completed to assess teachers' proficiency of virtual -technology use and best practice teaching strategies for delivering remote instruction. Consultants and Salmon River staff with expertise in identified pedagogy and technology will deliver Professional Development to staff to address gaps in pedagogy and technology, thus enabling teachers to be better prepared to provide quality lessons that fully engage students during remote and hybrid teaching situations.

No, the LEA does not intend to use ESSER funds to promote remote learning.

- 3. **In the space below, please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services (150 words or less).**

The District intends to assess and identify student learning gaps resulting from the disruption in educational services based on data collected and analyzed from new diagnostic assessments and/or pretests (assessments include but are not limited to: ready - Math and Reading diagnostics, Running records for reading and math, anecdotal progress notes from Spring, 2020 and summer sessions), an analysis of unit lesson plans and curriculum maps to identify curricula that was not taught during the closure, a review of student work, course grades, attendance and participation data, and the teacher-student-parent communication logs that were maintained to monitor student engagement and progress. To address the identified gaps, teams of Pre-K-12 teachers will meet as grade levels and also vertically to create consistency in planning for instruction. By doing so the teams will identify grade level standards curriculum materials and skills-related materials that must be shared from previous grade levels in order to fill these gaps during tier 1 instruction, while still teaching to present grade level standards. A two- tiered approach with classroom teachers and interventionists will target intervention for students with more intense needs. Increased frequency and smaller group sizes will be utilized in these tiers of services during both pull out and push in sessions, based on individual and class needs and availability of staff resources. Administration will be involved with teachers in this process to support curricular and staffing needs.
